

# Instructions for the *AFFIDAVIT OF SUPPORT* for GRADUATE INTERNATIONAL STUDENTS

Financial proof must be provided to comply with U.S. Government regulations. Your Affidavit of Support for Graduate International Students must originate from your source of support.

Submit your *Affidavit of Support for Graduate International Students* with your application and other admissions documents. Final admission is not granted until the Office of Admissions is satisfied that all documents are complete and correct. At that time your immigration document will be issued.



#### **REQUIREMENTS for ACADEMIC YEAR 2019-2020**

For <u>doctoral</u> students **without** a graduate assistantship who bring no dependents, financial proof is required for **U.S. \$36,279.00**.

For all <u>Master's</u> students and <u>doctoral</u> students **with** a graduate assistantship who bring no dependents, financial proof is required for **U.S. \$45,187.00**.

For Master's and Doctoral students with an assistantship, stipend is less than **U.S. \$16,584.00**, you will need to show financial proof of at least the difference between **U.S. \$16,584.00** and your assistantship stipend. You will be responsible for any portion of living expenses not covered by your assistantship stipend.

If you plan to attend summer school, proof is required for an additional **U.S. \$16,907.00** for tuition and fees, books, and miscellaneous expenses.

Additional financial proof is required for a spouse and/or children (see Affidavit of Support form for more information).

The Office of Admissions may require proof of additional funding as costs of attending Michigan State University may increase periodically.



### VERIFICATION of FINANCES

Verification of finances can be 1 or 2:

- Certification by a bank that you have funds available AND certification by person(s) responsible for your finances. This person must sign the *Affidavit of Support for Graduate International Students*. OR
- 2. Certification by a government, educational institution, or official agency. Proof of finances from a government, educational institution, or official agency must appear on official stationery and contain an original seal and signature(s).
